- I. Update from Census 2020 Program Administrator
 - David Schawb, Senior Consultant, The William Everett Group
 - Met with 13 Cook County Commissioners to gather insight into outreach approaches, hard-to-count maps, resources, and languages
 - Created district specific outreach plans that will be finalized and distributed in December
 - Attended outreach events such as Univision POSIBLE Chicago Expo, Hazel
 Crest homeowners meeting, and others to promote 2020 Census
 - Completed the review and recommendation process for 1st round of census outreach applications
 - The William Everett Group applied for a grant with the Metropolitan Mayors' Caucus for additional advertising and marketing
 - o Updates from the Bureau of Economic Development
 - Census Champions
 - Recruitment within Cook County government to serve as "census champions" and creating customized help books for individuals to communicate with hard-to-count communities
 - Print materials and giveaways
 - Working with The William Everett Group to develop refreshed print assets such as postcards, posters, and window signs
 - Developing new giveaway items to promote census engagement
 - Press, media buy, and social media
 - Creating media buy plans and beginning advertising and social media campaign
 - Alignment and data
 - In conversation with City of Chicago, State of Illinois, and U.S. Census Bureau regarding marketing and advertising
 - In the process of reviewing the U.S. Census Bureau's 2020 response data
- II. Review of 1st Round Census Outreach Applications
 - David Schwab, Senior Consultant, The William Everett Group
 - o 79 applications were received
 - 52% of the applications were from the City of Chicago and 48% were from the suburban region of Cook County
 - Application rubric used that considered the following factors:
 - Reach and potential impact into hard-to-count (HTC) populations
 - Experience in HTC communities
 - Project plan and project feasibility
 - Agency capability, mission, goals, and experience
 - Additional review factors
 - Equity of funds distributed



- · Area of need
- Potential impact of agency/group
- Other grant funding received
- Expenditures were approved or denied by line item
- o 61 of 79 applications are recommended for approval
 - Recommend a total of \$1,423,257
 - 43 recommended awardees are Local Complete Count Committees and 18 recommended awardees are Local Government Complete Count Committees
 - Range of awards recommended: \$2,340 \$25,000
